## Introduction

The qualification is aimed at individuals who have an interest in the Machine Method of Cosmetic Micropigmentation for the Face and Body, and for individuals who work within the beauty industry and want to expand their talents or upgrade their existing certification to a regulated qualification. Candidates can choose one or more of the following micropigmentation treatments for eyebrows-stroke effect, eyebrows-powder effect, eyelash thickener, eyeliner, shaded eyeliner, lipliner, full lip colour and areola. In addition, they will learn about Health and Safety in a salon or clinic setting, Personal Protection, Client Care and Consultation techniques, Colour Theory and Pigment selection, Equipment and Needle Choice, as well as aftercare and follow-up.

The awarding organisation for this qualification is ProQual Awarding Body and the regulatory body is the Office of Qualifications and Examinations Regulation (Ofqual).

## Entry Requirements

Candidates are required to have achieved a Level 3 qualification in this area of beauty or hold certificates that have relevancy from prior learning.

Centres should carry out an **initial assessment** of candidate skills and knowledge to identify any gaps and help plan the assessment.

### Staff

- candidate test papers

**Learning outcomes** set out what a candidate is expected to know, understand or be able to do. **Assessment criteria** specify the standard a candidate must meet to show the learning outcome has been achieved. *Learning outcomes and assessment criteria for this qualification can be found from page 8 onwards.*

In order to demonstrate competence there must be evidence that the candidate has carried out the procedure for:

(a) **FIVE** different clients covering the range of:

- full consultation
- area examination
- anaesthetics selections
- eyebrows
- eyelash thickener
- eyeliner and shaded eyeliner
- lip liner and full lip colour
- areola

(b) **THREE** different clients covering various pigmentation treatments:

- organic and non-organic products
- mixing pigments correctly
- needle depth variation
- machine method
- mapping techniques
- strokes and powder effect

## Internal Quality Assurance

An internal quality assurance verifier confirms that assessment decisions made in centres are made by competent and qualified assessors, that they are the result of sound and fair assessment practice and that they are recorded accurately and appropriately.

## Adjustments to Assessment

Adjustments to standard assessment arrangements are made on the individual needs of candidates. ProQual's Reasonable Adjustments Policy and Special Consideration Policy sets out the steps to follow when implementing reasonable adjustments and special considerations and the service that ProQual provides for some of these arrangements.
